- Cards are required to be presented at check-in to use your season pass. Pass holder must be the one to present their pass at check-in. Your card acts as your form of payment as well as your form of identification.
- If a card is lost or stolen, there will be a \$15 replacement fee

2024 Season Pass Classifications

Conditions for Resident Status: A player must be a year-round resident of the Town of Auburn and must present **two proofs** of the same upon application: (auto registration, driver's license, utility bill or other proof of residency approved by the Town).

Unlimited Pass: Pass provides for unlimited rounds of golf on weekdays, weekends and holidays, excluding special events and tournaments.

Junior: Any youth age 18 and under, pass provides for unlimited rounds of golf on weekdays, weekends and holidays, excluding special events and tournaments.

Senior: Must be (62+) at the time of purchasing the pass

HOURS OF OPERATIONS

- The course shall be open for play, weather permitting.
- No play shall be allowed outside the hours of operation. Check with clubhouse staff.
- Any changes to the hours of operation shall be posted at the course, on the website and on social media pages.

STARTING TIME POLICIES

- Tee times are taken up to 7 days in advance. For example, a player may call for a Saturday tee time beginning the previous Saturday.

GENERAL RULES, SAFETY AND ETIQUETTE

Please keep in mind these general golf course rules and regulations during play

Note: Golfers assume full personal liability for all actions while using this facility.

The following is strictly prohibited. Violators may lose golfing privileges.

- Playing when the Course is closed (see hours of operation).
- Practicing on the Course.
- Playing more than one ball.
- Starting on any tee other than the 1st without the permission of the Pro Shop.
- Stealing golf course property or damaging rentals/property.
- The clubhouse has the right to make changes at any time.

General Rules

- Each player must have his or her own set of clubs.
- Golf carts cannot be guaranteed. Available carts will be passed out in the order of tee times.
- Every person must pay a greens fee to have access to the course, including spectators and those who want to walk with a player must pay a greens fee. If the group is riding you must pay the greens fee plus the full cart price.
- **Every player (pass holders included) must register in the Pro Shop prior to play.**
- Proper conduct and language at all times. Verbal abuse of staff or other golfers shall result in suspension of player's use of Pakachoag Golf Course and facilities.
- Players with handicaps/mobility issues may approach greens to accommodate their needs. At no time can carts be driven on tees/greens or approach collars.
- Holes must be played in succession.
- No rain checks will be given.
- Play ready golf, replace all divots, Fix your ball mark as well as others.

Safety:

- Keep in mind the safety of rangers and maintenance staff.
- No playing from out of bounds (designated by white stakes).
- Leave golf course in the event of lightning or staff lightning warning.
- Be aware of your limits. Do not hit into the group in front of you.
- One group on a tee box at a time.
- Allow faster players to play through.
- Keep carts and pull carts away from tees and greens.
- When flags are out of cups, maintenance staff has right of way.

Nets and Putting Green:

- No Practicing (Driving and Chipping) beyond designated areas, marked with signs

EXPULSIONS and APPEALS

SUSPENSION OR EXPULSION and APPEALS:

The Clubhouse Staff and the Course Staff shall enforce the rules of Pakachoag Golf Course. Violation forms may be given to players for infractions. Immediate suspension may result for serious violations. The Town of Auburn, may expel or suspend any player for any and all egregious confirmed violations of Golf Course rules and policies or in the event of a Golfing or Permit Holder's receipt of two or more violations during the course of a season. The person shall be notified by the Department as to the active date of suspension or expulsion. A player may appeal their suspension or expulsion notice to the Town Manager, or his designee prior to the activation date of said suspension by requesting a hearing. In the event no written contact is made prior to the activation date, suspension or expulsion shall begin on that date. Suspended players are not entitled to refunds or credits during their suspension. A hearing shall be set up upon request within a reasonable time frame. The player may bring with them any written information, witnesses, or other materials they feel may help their cause. All judgments at the hearing shall be final.
